In all instances, it is the aim to promote, praise, reward and celebrate all positive learning, conduct and emotional behaviour choices.

### Behaviour Levels – Examples and consequences overview

## Low

Refusing to complete work

Running around school
Talking during assembly
Writing notes/drawing during lesson
Talking during lessons (2nd warning)
Leaving the classroom without permission
Not packing away when asked / not being ready for learning
Not settling down to work (or an appropriate activity) on entering the classroom

# **Yellow Card**

Not letting others play in games
Saying unkind things about others
Spoiling / disrupting other's games
Unfair sportsmanship
Talking in the line
Running to the line after the whistle has blown
Running before the designated line

Time out
Fixed time accompanying adult on duty
Apology
Removal from game / activity

## Red Card

Any use of hurtful physical actions (eg pushing / kicking etc)

Any use of inappropriate language

2nd yellow card

Refusing to follow the adults instructions

Taken, with supervision, to Key Stage Leader
